### **CURRICULUM VITAE**

#### **of Panagiotis Tsogias**

- I was born in 1965 (19<sup>th</sup> of August) in Thessaloniki and I am 43 years old.
- I live and work in Thessaloniki, I am married and I have a 12 years old son.
- In the year 1983, I graduated from Institute “Anatolia” American College of Thessaloniki.
- In the year 1988, I graduated and I got the basic diploma from the Law School of University Thessaloniki.
- In the year 1993, I got my first master degree in criminal law from the Criminal Law Department of the Law School of University Thessaloniki.
- In the year 2004, I got my second master degree in civil and civil procedure law from the Civil and Civil Procedure Law Department of the Law School of University Thessaloniki.
- During the years 2004-2007, I worked out and finally in 2007, I completed and presented my doctoral thesis in a special subject of civil procedure and execution law and I was nominated doctor of law science of the Law School of University Thessaloniki.
- In the year 2008, my thesis was printed and published in book, by the law publishing house named “Sakoulas” with the title : «Substitution in the place of creditor who imposed seizure and continuation of the auction procedure” (“Subrogation dans les poursuites”).
- During these years some articles of mine, have been accepted and have been published in greek law science magazines.
- I am scientific collaborator in greek law scientific magazine named “Review of Civil Procedure”
- Since 1988, and for 20 continuous years I practice as a lawyer in Thessaloniki and in supreme courts in Athens.

- I am the legal counsellor of the YMCA Thessaloniki organization and of the athletic and team department of YMCA Thessaloniki, so during these last years I have been occasionally concerned with some cases in greek athletic law and in supreme athletic courts.
- I am a member of the legal commission and of the athletic commission of YMCA Thessaloniki.
- During the decade 1980-1990, I was an athlete of the YMCA handball team, with about 100 participations.
- Since the year 2002 I am leader director of youth handball teams of YMCA (ages between 10-18) and I have participated with my teams in many official final tournaments of the greek championship and in the international tournament of Partille.
- In elections of Hellenic Handball Federation (2-11-08) I was elected as a substitute member of HHF and I am a member of handball development commission of the HHF.
