

## **EHF GIVEAWAY**

### **TERMS AND CONDITIONS**

When you enter and participate in an EHF Giveaway (the "Giveaway"), your participation shall be governed by these Terms & Conditions, the rules of the relevant Giveaway and any other materials relating to the Giveaway published on the relevant EHF Platform.

Informative and explanatory material relating to the Game (including instructions for the competition and the scoring system) and the Rules form part of these Terms & Conditions.

#### **1) Online engagement tools promoter**

The **European Handball Federation**, Platz des Europäischen Handballs, Baumgasse 60A, A-1030 Vienna, Austria (the "EHF"), has developed the Giveaway, to be structured and regulated in accordance with the present T&Cs, the applicable Austrian National Legislation and European laws on Games of Chance.

#### **2) General Information**

The EHF is the controller of the data processed by EHF Marketing GmbH in its capacity as a processor, in accordance with the EU General Data Protection Regulation (GDPR).

The Giveaway is no way sponsored, endorsed, administered by, or associated with Meta platforms (e.g., Instagram, Facebook) or X. By entering the Giveaway, all participants provide a full release of the above-mentioned platforms.

#### **2a) Promotion period**

The Giveaway is active on the EHF Champions League Official Instagram account (@ehfcl\_official), EHF Champions League Official Facebook account (@EHF Champions League), EHF Champions League Official X account (@EHFCL), from 4 September 2025 06:00:00 CEST until 8 September 2025 23:59:59 CEST.

#### **2b) Eligibility**

is/are given away. The announcement of the winner will be communicated via private message on the respective social media platform.

All natural persons above the age of 18 are eligible to participate and win prizes, provided they follow the instructions in the social media post and comply with the hereinunder described proceeding to participate in the Giveaway. Employees, agents, officers, and directors of EHF as well as their respective parent companies, subsidiaries, affiliates and employees may not participate and are not eligible to win prizes in any available categories.

The EHF reserves the right to re-do the raffling should shipping to the firstly selected winner's location prove logistically challenging and/or impossible within a reasonable time period.

## **2c) Prize awarding**

The selection of winners will be conducted through a random raffle method among all eligible participants who meet the giveaway criteria. The raffle will be executed using an unbiased and transparent process, ensuring each eligible participant has an equal chance of being selected. The winners will be chosen at random and without bias from the pool of eligible entries received.

The results of the raffle will be deemed final and binding. ## **2d) Notification of winning**

No transfers, cash awards, or prize substitutions are permitted. The potential prize winner will be notified via email. If a potential prize winner cannot be contacted, or is ineligible according to these Terms and Conditions, or prize notification is returned as undeliverable, or decides to decline his/her prize for any reason whatsoever, or fails to fully comply with these official rules, he/she will forfeit his/her prize and the prize may be awarded to an alternate prize winner from among all remaining eligible entries received for the applicable drawing, at EHF's sole discretion.

Once the official contact has been carried out within the specified time period in accordance with Austrian National Legislation, verified, and receives final approval by promotion entities, then and only then will a potential prize winner become an actual winner.

Users may revoke their consent at any time and without providing reasons, with effect for the future. If you revoke your consent to the processing of personal data, you are no longer entitled to participate in the Giveaway selection as pertaining to a currently active Giveaway.
